\*Preschool will be in session all week, Monday through Friday.

\*3 yr old Morning Session-The morning session will run from 8:30 am to 11:30 am. Optional bus services will be available to transport your child to school at the start of the school day. Parents are responsible for transportation at the end of the morning session at 11:30 am. The options of breakfast and lunch are available for children enrolled in the morning program.

\*4 yr old Afternoon Session-The afternoon session will run from 12:45-3:45 pm. Parents are responsible for transportation to school at 12:45 pm. Optional bus services will be available at the end of the day at 3:45 pm. Lunch is an available option for children enrolled in the afternoon program.

\*To be enrolled in the 3 or 4-year old program, your child **must be 3 or 4** years old on or before August 31, 2024.

\*A yearly fee of \$66 per child will be assessed for the Preschool program.

\*Documents needed when enrolling a child in Preschool for the first time are: Birth Certificate, Social Security Card, Immunization Records and a current Health Assessment or Physical administered by the County Health Department or your private physician. These documents should be brought to the school when paying fees in August.

\*Once you fill out an application for Preschool, you will be notified if your application has been accepted.
